



**GO FOR GOOD PROTEIN SWEEPSTAKES**

**OFFICIAL RULES**

Non-winning entries **will** carry forward into subsequent Entry Period drawings but **will not** carry forward into subsequent Phases. The Administrator’s computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Entrant must also attach to the email, one (1) photo of his/her corn dog dressed up or decorated with the Foster Farms 16 ct. Corn Dogs box in the background and clearly visible. Photos must be in .JPEG, .JPG, or .GIF format (no PDFs will be accepted) and may not exceed 5 MB. Entrant will earn one (1) entry into the applicable Entry Period of Phase 1 for successfully emailing the requested information and attaching a photo. There is a limit of one (1) entry per day via this method from June 1, 2018 through June 14, 2018.
- ii. **Upload A Photo Online From 12:00 PM ET on June 14, 2018 through July 15, 2018:** From 12:00 PM ET on June 14, 2018 through July 15, 2018, an eligible entrant may visit [www.GoForGoodProtein.com](http://www.GoForGoodProtein.com) ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), and valid e-mail address. Entrant may then follow the links and instructions to upload one (1) photo of his/her corn dog dressed up or decorated with the Foster Farms 16 ct. Corn Dogs box in the background and clearly visible. Photos must be in .JPEG, .JPG, or .GIF format (no PDFs will be accepted) and may not exceed 5 MB. Upon the successful submission of the registration information and photo upload, an entrant will receive one (1) entry into the applicable Entry Period of Phase 1. There is a limit of one (1) entry per day during the Sweepstakes Period.
- iii. **Mail-In Without Uploading A Photo:** To earn a Sweepstakes entry without e-mailing or uploading a photo online during Phase 1, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. **B. Phase 2:**

- i. **Make A Purchase:** During Phase 2 of the Sweepstakes Period, an eligible entrant may purchase two (2) Foster Farm Chicken Nuggets, Foster Farms Corn Dogs, Foster Farms Chicken Strips or any Foster Farms Frozen Cooked Chicken products ("Qualifying Product"), while supplies last, at a participating retailer. Entrant then must visit the Website and complete and submit the registration form (if he/she has not already done so) including, but not limited to: his/her first and complete last name (no initials), and valid e-mail address. Entrant must then follow the on-screen prompts to upload a photograph of the original register receipt showing the Qualifying Purchase. Each entrant should circle the Qualifying Product on the receipt

Each receipt must show the purchase of one (1) Qualifying Product. The file must be in .JPEG, .JPG, or .GIF format (no PDFs will be accepted) and may not exceed 5 MB. Following this method of entry, an entrant will receive one (1) entry into the applicable Entry Period of Phase 2.

- ii. **Mail-In Without Making A Purchase:** To earn a Sweepstakes entry without making a purchase during Phase 2, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Entrant may then follow the links and instructions to upload one (1) selfie photo. Photos must be in .JPEG, .JPG, or .GIF format (no PDFs will be accepted) and may not exceed 5 MB. Upon the successful submission of the registration information and photo upload, an entrant will receive one (1) entry into the applicable Entry Period of Phase 3.

**Mail-In Entries:** All Mail-In Entries must be postmarked by and received by the dates indicated in the charts above in Section 1. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

**Photo Entry Requirements:** All photo entries must comply with the following restrictions:
